Resolution 23-16

Highway Transportation Funding

WHEREAS, local government in Wisconsin is responsible for about 90% of the road miles in the state; and

WHEREAS, Wisconsin's diverse economy is dependent upon county and town roads as well as city and village streets and transit systems across the state; and

WHEREAS, according to "Filling Potholes: A New Look at Funding Local Transportation in Wisconsin," commissioned by the Local Government Institute of Wisconsin (LGI) the condition of Wisconsin's highways is now in the bottom third of the country; and

WHEREAS, state funding for local roads in Wisconsin has failed to keep up with costs over the past several decades which has adversely affected local transportation finances.

According to "Filling Potholes," municipal transportation spending has declined from \$275 per capita in 2000 to \$227 in 2012; and

WHEREAS, Mass Transit Operating Aids and County Elderly and Disabled Transportation assistance programs are funded through the state gas tax and vehicle registration user fee system. These programs are critical to ensuring that transportation services are delivered to vulnerable citizens. Proper funding for these programs helps ensure that all citizens have an opportunity to access the workplace as well as the marketplace; and

WHEREAS, levy limits do not allow local government to make up for the deterioration of state funding; and

WHEREAS, Wisconsin's over-reliance on borrowing eats away at the state's segregated funding sources - the state gas tax and vehicle registration fees - which increasingly pay debt service rather than fund transportation needs; and

WHEREAS, safety is a primary concern and responsibility of local governments across Wisconsin. Unfortunately, according to TRIP, a national non-profit transportation research group, Wisconsin had 347 non-interstate, rural road fatalities in 2013; and

WHEREAS, the Price County Board of Supervisors recognizes that our state highway and interstate system is the backbone of our surface transportation system and plays a vital role in the economy of Wisconsin. Both local *and* state roads need to be properly maintained in order for our economy to grow; and

WHEREAS, from a competitive standpoint Wisconsin motorists pay significantly less than any of our neighbors when you combine the annual cost of the state gas tax and vehicle registration fees; and

WHEREAS, the Transportation Finance and Policy Commission, appointed by the Governor and Legislature clearly found that if Wisconsin does not adjust its user fees, the condition of both our state and local roads will deteriorate significantly over the next decade.

NOW, THEREFORE, BE IT RESOLVE by the Price County Board of Supervisors urges the Governor and Legislature to *Just Fix It* and agree upon a sustainable solution: one that includes a responsible level of bonding and adjusts our user fees to adequately and sustainably fund Wisconsin's transportation system. Furthermore, the Price County Board of Supervisors directs the County Clerk to send a copy of this resolution to our State Legislators and to Governor Scott Walker.

Resolution 26-16

Cooperation Agreement for Community Development Block Grant –

Emergency Assistance Program (CDBG-EAP)

This agreement entered into on the 16<sup>th</sup> day of August, 2016 by and between Price County and the  
Counties of Ashland, Bayfield, Burnett, Douglas, Iron, Sawyer and Washburn.

WHEREAS, Price County has an identified Emergency Assistance need in the municipalities resulting  
from a natural disaster; and

WHEREAS Price County contemplates submitting jointly with the Counties of Ashland, Bayfield, Burnett,  
Douglas, Iron, Sawyer and Washburn an application for funds under the Small Cities Community

Development Block Grant - Emergency Assistance Program of the Wisconsin Division of Energy, Housing and Community Resources for the purpose of meeting those needs; and  
WHEREAS, Price County and the Counties of Ashland, Bayfield, Burnett, Douglas, Iron, Sawyer and Washburn desire to and are required to, enter into a written cooperative agreement with each other to participate in such CDBG-EAP program; and  
WHEREAS, Price County and the Counties of Ashland, Bayfield, Burnett, Douglas, Iron, Sawyer and Washburn understand that Iron County will act as the applicant and will have the ultimate responsibility to assume all obligations under the terms of the grant including assuring compliance with all applicable laws and program regulations and performance of all work in accordance with the contract; and  
WHEREAS, it is understood that the Department of Housing and Urban Development and the Wisconsin Division of Energy, Housing and Community Resources will have access to all participants' grant records and authority to monitor all activities.

NOW THEREFORE BE IT RESOLVED, pursuant to §66.0301 Wisconsin Statutes, Price County and the Counties of Ashland, Bayfield, Burnett, Douglas, Iron, Sawyer and Washburn agree to cooperate in the submission of an application for such funds, and agree to cooperate in the implementation of the submitted CDBG-EAP program, as approved by the Department of Administration, and the Division of Energy, Housing and Community Resources.

Nothing contained in this agreement shall deprive any municipality of any power or zoning, development control or other lawful authority which it presently possesses.

Approve Temporary Beeper Pay for Health and Human Services Department (HHSD) Employees – Crisis Mental Health Services

WHEREAS, Price County is required to furnish crisis mental health services to the citizens of Price County; and

WHEREAS, the current provider of those services for Price County has terminated their contact with the County; and

WHEREAS, the County is actively searching for a provider for such services; and

WHEREAS, in the meantime, HHSD Crisis Mental Health Social Workers will be providing the crisis mental health services beginning August 8, 2016 and going until the County contracts with a new service provider; and

WHEREAS, the County will offer beeper pay to employees who will be on-call to provide this 24/7 coverage; and

WHEREAS, consistent with Social Workers in the Children and Youth Unit of HHSD, Crisis Mental Health Social Workers shall be required to carry the on-call cell phones and respond to after-hours calls on a rotation scheduled by the unit supervisor; and

WHEREAS, the Crisis Mental Health Social Workers shall be paid a per diem corresponding to the following schedule:

- Weekdays (M-F) \$35
- Weekends \$51
- Holidays \$50

NOW THEREFORE BE IT RESOLVED, that the Price County Board of Supervisors approves the temporary beeper pay for Health and Human Services Department Employees – Crisis Mental Health Social Workers.



  - d. Forestry & Parks – Heikkinen: Stumpage at \$986,172 with two active sales. Campgrounds have been full on weekends. Red pine being replanted.
  - e. Health and Human Services – Pluemer: 25% increase in juvenile offenders. Public Health offering blood pressure clinics and dealing with animal bite cases. Crisis mental health service is being done by staff until provider can be contracted. Home delivery of meals continuing. BART bus going well with 50 riders per week. Recruiting Income Maintenance Specialist.
  - f. Highway & Transportation – Palecek: Airport – Sealcoat scheduled August 22<sup>nd</sup>. Fly-in went well. Traffic and fuel sales are up. Highway – crack filling, rut paving, ditching, striping. Highway 86 and other areas storm damage. Counties B and J are under construction.
  - g. Land Use & UW-Extension – Kopisch: Zoning permits are up. Several conditional use permits. Land Conservation is busy with summer projects. UW-Extension had one position cut - which wasn't being filled. State still unclear on budget implications.
  - h. Law Enforcement – Hintz. Sheriff Schmidt reported on testing for staff, field training for new hires, missing person in Prentice area, inmate medical expense will be over budget, self-defense course for school bus drivers.
6. County Administrator's Report – Nick: Working with Hedlund Agency on health insurance. New contracted Animal Control Officer starts September 1<sup>st</sup>. Some of the Highway crews have been working out of county to assist in storm damage. Negotiating with Town of Worcester on Old 13 Road issue. New Tourism visitors guide being done jointly with Park Falls and Phillips. UW-Extension has gone from 3.6 to 2.6 state employees. Two resolutions for next Board meeting - \$450,000 IT project for storage servers to be financed with a three year loan and moving forward with the \$3.8 million Safety Building remodel.



WHEREAS, the Executive Committee has identified the need for the capital project of upgrades to the County computer storage systems with an estimated cost of \$450,000; and


WHEREAS, the Executive Committee has reviewed the financial impact of this project and recommends short-term borrowing to finance this project.


WHEREAS, the profit from the 2015 land sales was \$2,831, the entire amount of which shall be transferred into the Capital Improvement Fund.



**Support of Increased Funding in the Children and Family Aids Allocation**

WHEREAS, the Department of Children and Families provides funding to counties through the Children and Family Aids allocation for the provision of child abuse and neglect services, including prevention, investigation, treatment, and out-of-home placement costs; and

WHEREAS, base funding for child welfare services has not increased since the Department of Children and Families was created in 2009; and

WHEREAS, over the past few years, the child welfare workload has increased in all counties across the state; and

WHEREAS, the number of child protective services (CPS) referrals has increased by 30 percent since 2007 – from 55,895 referrals in 2007 to 72,698 in 2014; and

WHEREAS, the number of children in out-of-home care has increased from 7,653 in 2011 to 8,258 in 2015; and

WHEREAS, the number of screened-in CPS reports has increased from 18,706 in 2011 to 20,384 in 2015; and

WHEREAS, the number of Children in Need of Protection and Services (CHIPS) petitions filed with the court has increased 12.5 percent from 2008 to 2015; and

WHEREAS, the number of Children in Need of Protection and Services (CHIPS) petitions filed in Price County Juvenile Court at the end of August, 2016, is twice the number of total CHIPS petitions filed in 2015; and

WHEREAS, counties are struggling to recruit and retain child welfare workers; and

WHEREAS, the stress of increasing caseloads is taking its toll on CPS workers, causing many experienced child welfare workers to leave the profession; and

WHEREAS, the leading cause of these increases is the use of heroin, opiates, and methamphetamines; and

WHEREAS, it is critical that counties have the resources necessary to ensure the safety of children in every corner of the state; and

WHEREAS, counties are struggling to identify resources to increase child welfare staff, especially given the significant overmatch counties already put in the human services system.

NOW, THEREFORE, BE IT RESOLVED that the Price County Board of Supervisors does hereby request that the state of Wisconsin, in the 2017-19 state biennial budget, increase funding to counties in the Children and Family Aids allocation to assist counties in serving the increasing number of children and families in the child welfare system; and

BE IT FURTHER RESOLVED that a copy of this resolution be sent to Governor Scott Walker, Department of Children and Families Secretary Eloise Anderson, Department of Administration Secretary Scott Neitzel, area legislators, and the Wisconsin Counties Association.

WHEREAS, the forest management plan for a portion of this unit, which is currently in a nonproductive condition following the 1977 windstorm, is to prepare the site and plant it in red pine; and

WHEREAS, 3.17 miles of roads need to be built or reconstructed to facilitate adequate access to the management areas, with estimated projects cost of \$45,125; and

WHEREAS, the Forestry and Parks Department requested funding from the Wisconsin Department of Natural Resources (WDNR) for the project under the County Forest Sustainable Grant program; and

WHEREAS, the request was tentatively approved for a total of \$45,125 to complete reconstruction / construction of roadwork needed to facilitate access to the parcel; and

WHEREAS, the project will not only allow adequate forestry management of the parcel but will also allow access to citizens for public use.

NOW, THEREFORE BE IT RESOLVED THAT, Price County accepts the WDNR County Forest Sustainable Forestry Grant award in the amount of \$45,125 and directs the Forestry and Park Department to move forward with the sustainable forest project.
