Coroner's Report and Vouchers: Report and vouchers reviewed. Motion Vlach/Adolph to approve the vouchers totaling \$2,050.21. Motion carried.

District Attorney's Report and Vouchers: Vouchers were reviewed. Motion Adolph/Vlach to approve the vouchers totaling \$710.74. Motion carried.

Review of Shared Position for DA and Sheriff's Office: Discussion of position. Motion Adolph/Vlach to recommend to the Administration Committee to make this position full time with no further reviews. Motion carried.

Clerk of Circuit Court Report and Vouchers: Vouchers were reviewed. Motion Vlach/Adolph to approve the vouchers totaling \$8,106.69. Motion carried.

Sheriff's Report and Vouchers: Sheriff Schmidt reported that Chief Deputy Roush ordered a target system for the range. The system was recently shipped. The funds received from the Alert Challenge will be used for this purchase. No inmates were housed in other counties. The Sheriff's Office is looking at advertising for casual positions in the near future. Short discussion. Motion Vlach/Adolph to approve vouchers totaling \$37,775.52. Motion carried.

Law Enforcement Supervisor Field Training Officer Pay: The Sheriff gave an explanation of the situation and of the FTO program. Short discussion. Motion Vlach/Adolph to forward Law Enforcement Supervisor Field Training Officer Pay to the Administration Committee for further discussion and possible action. Motion carried.
