






# Juvenile Alcohol Citations Locations January 1, 2011 - December 31, 2011





# Juvenile Alcohol Citations By Month January 1, 2011 - December 31, 2011



# Juvenile Alcohol BAC Level Statistics January 1, 2011 - December 31, 2011
















