

The notice shall contain a statement that the person has the right to demand that the evidentiary hearing or meeting be held in open session. This paragraph and par. (f) do not apply to any such evidentiary hearing or meeting where the employee or person licensed requests that an open session be held and (c) for considering employment or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility for the purpose of:

 - b. Return to Open Session
