## Request for Proposals

### PULVERIZING

County Highway D- Chequamegon Drive South  
Project Length 1.4 Miles

Sealed proposals will be received by the Price County Highway Department until 8:30 AM on February 13, 2024.

Pulverize the full depth of the existing asphaltic surface (22' Wide and Approximately 2" Depth) until 97% or more will pass the 2" (50mm) sieve. Also pulverize the existing base to a depth determined by the Highway Department to mix the pulverized asphaltic material. Traffic control will be provided by Price County Highway Department.

- Specify size of machine (HP, width)
- Proposals will be by the linear mile on varying width pavements.
- Pulverizing scheduling will have to coincide with asphalt plant availability.
- Water injection option

Mail or deliver Proposals to the Price County Highway Department, 704 North Lake Ave., P.O. Box 169, Phillips WI 54555. Proposal envelopes must be sealed and marked as "CTH D Pulverizing" and include a complete Proposal Form. Proposals received will be evaluated at the February 13, 2024, meeting of the Highway and Transportation Committee at 9:00 A.M. at Price County Board Room 101. The Highway and Transportation Committee reserves the right to reject any or all proposals or portions thereof, to accept any or all proposals or portions thereof and to waive any technicalities in any proposal deemed most advantageous to Price County.

**PREVAILING WAGE REQUIREMENTS:** The Contractor will be responsible for any prevailing wage rates as determined by the scope of the project. The contractor is responsible for obtaining the proper documents from the Wisconsin Department of Workforce Development prior to beginning any work. All work described here-in is subject to the provisions of Section 66.0903 Wisconsin State Statutes.

**INSURANCE REQUIREMENTS:** During the term of the Contract, the Contractor shall, at the Contractor's own expense, purchase and maintain the following insurance in companies properly licensed and the satisfactory to the Owner. The limits of liability for the insurance required shall provide coverage for not less than the following amounts and shall provide greater coverage where required by law:

Successful proposer shall not commence work under this Contract until all insurance required under this paragraph is obtained, and such insurance has been approved by the County, nor shall successful proposer allow any subcontractor to commence work on their subcontract until all similar insurance required of the subcontractor has been so obtained and approved.

- (1) Worker's Compensation, including Occupational Disease and Employer's Liability Insurance.
  - a. Statutory – Amounts and coverage as required by the State of Wisconsin and the U.S. Government including the "All States" endorsement.
  - b. Employer's Liability – at least \$1,000,000 each accident
- (2) Comprehensive General Liability
  - a. Bodily Injury:
    - \$1,000,000 Each Occurrence
    - \$2,000,000 Annual Aggregate, Products and Completed Operations
  - b. Property Damage:
    - \$1,000,000 Each Occurrence
    - \$2,000,000 Annual Aggregate
  - c. Property Damage liability insurance will provide Explosion, Collapse and Underground coverage where applicable.
- (3) Comprehensive Automobile Liability
  - a. \$1,000,000 Each Person
  - \$2,000,000 Each Accident
  - b. Property Damage
    - \$1,000,000 Each Occurrence

No policy may be cancelled or changed in limits, extent of coverage or expire prior to final acceptance by Owner without fifteen (15) days prior notice to the Owner. The Contractor agrees to hold Owner harmless from damage claims that are not covered by insurance and arise from the Contractor's performance.

Prior to beginning any work, successful proposer shall furnish the County with a Certificate of Insurance, counter signed by a Wisconsin Resident Agent or Authorized Representative indicating that successful proposer meets the insurance requirements indicated above. The Certificate of insurance shall include a provision prohibiting cancellation of said policies except upon thirty (30) days prior written notice to the County and specify the name of the contract of project covered. A copy of the Certificate of Insurance shall be delivered to Price County fifteen (15) days prior to execution of this agreement for final approval. Upon renewal of the required insurance and annually thereafter, the County shall receive a new Certificate of Insurance for three (3) years after completion of the project. The Certificate shall describe the Contract by name and/or identification in the "Description of Operations" section of the form.
